University of Canada Egypt (UCE) Financial Summary Prepared for Senate, February 2025

UPEI has an agreement with Canwell Canada who is responsible for operating University of Canada Egypt (UCE). The current agreement is in effect until August 31, 2025.

Financial arrangements are as follows:

- tuition fees charged by UCE in respect of the Programs shall be determined by UCE.
- UCE Students registered in the Programs at UCE shall pay their fees at UCE
- UPEI issues installment invoices to UCE throughout the year and then reconciles the
 payments with the actual student enrolments to calculate any amount that may be
 owed. This reconciliation occurs in the summer following the academic year and any
 final adjustments are made to the amounts owing.
- UPEI has an internal formula to share all revenues received from UCE once all the revenues are received and reconciled.
- UCE is solely responsible for all expenses incurred by UPEI in respect of the offering of the Programs at UCE

UCE payment to UPEI are calculated as follows:

Undergraduate courses:

UCE pays \$1,050 CAD per full-time undergraduate student or \$105 CAD per course for students registered in less than ten 3-credit hour courses to the university.

Graduate courses (MBA):

UCE pays UPEI a fee of \$1,700 CAD per full-time student registered in the MBAGL program, or a fee of \$121 per course for students registered in less than ten 3-credit hour courses per academic year to the university.

UPEI revenue sharing model is as follows:

50% of the revenue is allocated to the Academic Unit (AU)

10% to each of:

Robertson Library

Registrar

President

5% to each of:

Vice-President Academic and Research

ITSS

Vice-Presient Administration and Finance

Comptroller

Further sharing occurs among Academic Units when a student from one academic unit takes a course from another faculty, the Academic Units share the revenue for those students 50/50.
